




Guest Speaker: Jerry Parisella

State Rep. Parisella provided some highlights of the recently-passed state budget. Concern about a budget deficit to the tune of \$4-\$5 billion due to the pandemic proved unfounded, as the legislature was able to pass a \$48 billion budget (2% higher than last year). Beverly is receiving \$10.6 million for our schools, and \$6.4 million local aid for police, fire, park. Specific earmarks for the Garden City include \$150k for advanced police/firefighter dispatch equipment and \$250k for road and traffic improvements. Significant assistance is being issued for Rental Vouchers (for when the eviction moratoriums are no longer in place), housing shelters, and environmental work - specifically upgrades for state and local parks. The state is allocating \$70 million for summer learning programs, to make up for learning lost to Covid restrictions. and \$30 million to emergency food assistance.

The Soldiers' Home in Holyoke, site of one of the pandemic's saddest events, will undergo a \$400 million rebuild.

Mass. will be net-zero for greenhouse gas emissions by 2050, the wind off the Cape will be put to good use for an Offshore Wind facility. Further investments will be made in Mass. tourism, and \$25 million will be provided for adult education classes for retraining. Finally, Rep. Parisella will be chairing the Economic Development Committee, where they will be considering allowing sports betting in the Commonwealth. 3 to 1 it passes.
