### Guest Speaker:

Robert Clayman is the founder and President of The Museum of Justice, Inc., (MOJ), a not-for-profit 501(C)(3) corporation with a growing Board of Directors. The MOJ is currently looking for a home or is a "tenant in search of a landlord." The MOJ is under consideration as one component of multipart proposals submitted by developers through a project managed by the Salem Redevelopment Authority to restore the Federal St. mid 1800's Superior Court building and the granite County Commissioners building.

Mr. Clayman is currently the Executive Director of the Massachusetts Judges Conference (MJC), the not-for-profit professional association of Massachusetts sitting and retired judges. His office is located at 71 Washington St., Suite 33 and 33A. He was hired in 2006 to re engineer the MJC's operations, communications, and service delivery systems. Now in his fifteenth year as Executive Director, voluntary membership consistently hovers at 86%, with close to 99% retention. He reports to 18 judges who serve as the elected officers and appointed Board of Directors.

The proposed home for the MOJ is the historic Essex County Superior Courthouse completed in 1891, located in Salem, MA. It will lift the curtain on a process that may seem complicated and opaque to the outsider. It will inspire an appreciation for fundamental rights and liberties, judicial independence, teach civic engagement, and responsibility, and provide a unique space for discussion on matters integral to our democracy. At its core, it will create a community of learners, ranging from those of elementary school age and older, to teachers, graduate students, and legal professionals, far beyond the borders of Salem. The MOJ will provide K-12 education, teacher training, public involvement and access, and will bring to light people's stories with the court and legal system. The MOJ is currently in the process of collecting letters of support. Email [rclayman@museumofjustice.org](mailto:rclayman@museumofjustice.org).

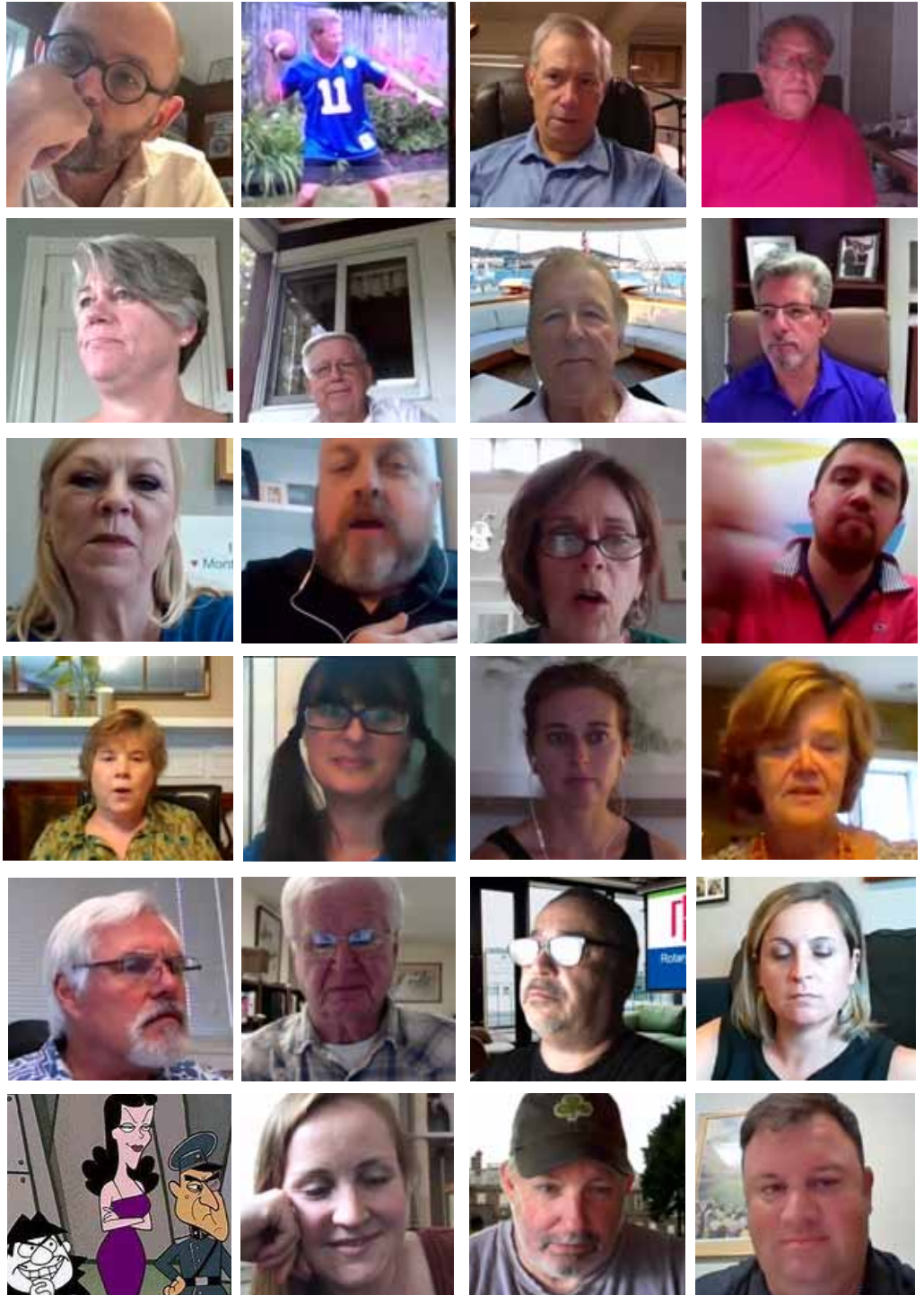
