The Swierczynski Swizzle Schtick



Every person who gets into law practice, dreams one day of being a presiding Judge, and even better if you get a "trial of the century" case. We step back into LAST century for a peek at Judge Lance Ito, who presided over the OJ Simpson trial, certainly worthy of a trial of the century. Not because of Ford Broncos making a comeback, nor football back in town, nor even the new sports card store on Cabot Street. More for the kind of drink a judge would need to get through a sideshow such as the OJ Trial was.
