Speaker: Paul Leighton of Salem News – pollution @Varian site on Sohier Rd Paul spoke to a group for the first time since he was in school. Stated we have a local newspaper crisis since 2,000 have gone out of business lately. Newspapers do seem to be appreciated more now. Varian contamination was made by the chemicals used to cleanup electronic components were dumped on ground behind building for many years. Came to light in mid-1980's. In the 1990's the state created agency to deal with matters such as these. State ordered Varian to clean up the pollution at, and in neighborhoods around site. During the pandemic, Paul saw a story about the Varian cleanup. He wondered why it had taken 30 years. The State Website created to inform residents affected was too complicated for average person to understand. He noticed a line chart with lines (indicating chemicals in ground) going up. Called David Lang and Jan Schlichtmann about it. Jan said cleanup was a f-ing failure! Residents didn't read glowing reports from a company Varian hired to cleanup neighborhoods. Paul talked to local officials about it and published initial story. Neighborhood started local group to look at issue. Ultimately, the state held that the Varian site cleanup was in non-compliance. Two-year deadline for Varian to come up with new cleanup plan (October 2022). Paul won several New England Newspaper Awards for the stories he wrote about Varian!

Reporter Paul Leighton gave us the lowdown on struggles of independent and smaller newspapers and the need for competition to snag a story. Luckily for us Sprocket an award winning independent paper has a wealthy benefactor that primes the pump and brings you fake news every week.

The Swierczynski Swizzle Schtick

Aloha. Yes, my unruly Rotarians, I realize that I could well "hold their (my) Office(s) during good Behavior" because, damn, I've been good. But don't hold me to it. Because I've got – count 'em – SIX WEEKS until Jonesy is elevated to top dawg. So how is it this week I am so perturbed I could spit? Which is why today I'm not contemplating the Supremes but thinking about spittoons. Spittoons in our Federal government to be specific. And since I can never opine and not imbibe, how about a porrón of cava for your thoughts? But more on that later. Chewing tobacco was popular in our government from the very first Congress into the 1900s when it slowly gave way to cigars and cigarettes. Hundreds of spittoons dotted the Capitol and tens of thousands of tobacco juice stains dotted the floors and walls around them, as accuracy was apparently a challenge to your average Member of Congress. The last holdout was the brass "Speaker spittoon" which steadfastly held its post near the Speaker's rostrum until the 1980s. The Supreme Court was no exception and even today a green porcelain spittoon remains in place next to each justice's big leather chair in the courtroom. What are they used nowadays?
